This juried gallery exhibit will showcase Contemporary Realism of South Florida, the focus of Art Evolution Gallery. Representational painters drawing from Impressionists, Expressionists, working in both studio and plein air will present artwork that speaks to savvy collectors. Application fee: \$25, deadline is September 4, 2024.

CALL for ARTISTS

This exhibit will be in the Art Evolution Gallery at Chapel 4 and online. The online exhibit will remain indefinitely with a link to artists website after the exhibit closes at Chapel 4.

Application fee: \$25, deadline is September 4, 2024. The fee is payable on-line by credit card and is non-refundable. Artists must include a 'completed' application, and release agreement, along with up to five high quality jpgs of original representational artwork. Images must be labeled as follows; artist's initials, the number that corresponds with your entry (1, 2, or 3), title of piece (or an abbreviation of the title). For example, DJW1OceanAtDelray.jpg. Overall, Image file size should be between 1Mb to 2 Mb in jpg file format. All submissions of artists paintings must be original work of the artist and not painted in a workshop (unless you were the instructor). All applications must be received by September 4, 2024.

Applications will be collected, and images will be reviewed for image quality and juried by the curatorial team of Art Evolution Gallery. The submitted image must be of good quality, well cropped to show only the painting as the image submitted is the image that will appear in the online exhibit. If you submit an image that does not meet standards for image quality, you will be notified and given a chance to resubmit another image. For actual artwork

The following must be adhered to:

- two dimensional originals only
- work must be framed and ready to be hung with wire included (tape wrapped wire would be appreciated)
- work can be in any medium
- work must be no larger than 2 sides adding up to 70" i.e., can be 40"x30"" or 50"x20". Etc.

TERMS OF ENTRY

The application fee is \$25.00 for registration, deadline is September 4, 2024.

The fee is payable on-line by applying to Www.artevolutiongallery.com/gallery/call by credit card and is non-refundable.

Via their on-line entry, artists must include a completed application, and release agreement, along with up to five high quality jpgs of original artwork. Images must be labeled as follows; your full initials, the number that corresponds with your entry (1, 2, or 3), title of piece (or an abbreviation of the title). For example, DJW1OceanAtDelray.jpg. File size for submitted images should be no larger than 2 MB and no smaller than 500Kb in size and a minimum 400 pixel wide. For actual artwork

The following must be adhered to:

- two dimensional originals only
- work must be framed and ready to be hung with wire included (tape wrapped wire would be appreciated)
- work can be in any medium
- work must be no larger than 2 sides adding up to 70" i.e., can be 40"x30"" or 50"x20". Etc.

All submissions must be original artwork, and not have been painted in a workshop (unless you were the instructor).

All applications must be received by September 4, 2024. (Incomplete applications will not be processed)

Applications will be collected, and images will be reviewed for image quality and juried by the curatorial team of Art Evolution Gallery. The submitted image must be of good quality, well cropped to show only the painting as the image submitted is the image that will appear in the online exhibit. If you submit an image that does not meet standards for image quality, you will be notified and given a chance to resubmit another image. After review by jury, all applicants will be contacted by September 18th, 2024, as to whether they have been accepted in this gallery & online exhibit. Accepted entries will also be given an opportunity to opt in to the Art Evolution Gallery Print on Demand site.
